Regarding Non-Transfer of vacant All India Quota seats (Session – 2013) to State Quota seats

Please refer to Directorate General of Health Services letter dated 08.07.2013 (copy may be seen below), as per the directions of the Hon'ble Supreme Court dated 03.07.2013 in Writ Petition (Civil) no. 433 of 2013, ***“.....In the meanwhile, the respondent States and Union Territories (Respondent no. 3 to 24) will not fill up the Post Graduate Medical seats belonging to the All India Quota”***.

In view of the direction of the Hon'ble Supreme Court the vacant All India Quota seats shall not be reverted to State Govt./ Quota till further orders of the Hon'ble Supreme Court.


Sir,

I am directed to invite your attention to the directions as per the directions of Hon'ble Supreme Court of India, in Writ Petition (C) No. 306 of 2004 in the matter of **Mridul Dhar Vs. Union of India**, wherein it has been directed that the first round of counseling in respect of post graduate seats should be over by all the concerned before 20th June 2013. For the current year, the date of completion of counseling is 31st July 2013. So far, the counseling under 'All India Quota' is concerned, this Directorate has already started it with effect from 04th June 2013. First round of all India counseling has been completed on 14th June 2013 and 2nd round has been completed on 03.07.2013.

In this connection, it is informed that this Department has received representations from some candidates that many States have still not started their first round of counseling for Post Graduate admissions, as per the schedule prescribed by Medical Council of India (approved by the Hon'ble Supreme Court of India). A writ Petition has also been filed by some candidates in Hon'ble Supreme Court of India vide W.P. (Civil) No. 433 of 2013 in this regard. The Hon'ble Supreme Court has passed an interim Order dated 03.07.2013 directing the respondents states and Union Territories not to fill up the Post Graduate seats belonging to the 'All India Quota'.

You are, therefore, requested to intimate by return e-mail/ FAX, whether you have completed first round of counseling as per the schedule approved by Hon'ble Supreme Court of India. If not, the reasons thereof may please be informed.
