

**WITHDRAWAL OF PG SEATS IN ROUND-2 OF AIQ COUNSELING IN  
MEDICAL COLLEGE'S OF BIHAR**

The Medical Counseling Committee has received letter from Deputy Secretary Govt. of Bihar regarding withdrawal of Postgraduate Seats from round-2 of AIQ-2016-17. The Deputy Secretary Govt. of Bihar has cited the reasons as mentioned in the letter (No. -1/Court-01/2013 (Part-II)-4621) dated 02/04/2016 & letter No. Court -01/2013(Part-II)-445(1) dated 31/03/2016 for removing the PG Seats.

The candidates already admitted to the above courses in Round-1 of All India Quota Counseling are requested to immediately contact the allotted college authorities for further up gradation of their seats in Round-2 of AIQ Counseling.

Sub: Regarding allotment of 50% All India PG Quota Seats.

Sir,

This is in reference to your letter no. सं०सं.1/कोर्ट/2013(खण्ड -II)-445(1) dated 31/03/2016 on the above mentioned subject.

In this context, it is to inform that as per the MCI Schedule approved by the Hon'ble Supreme Court of India, the First Round Result of online counseling of All India PG Quota Seats 2016-17 was published on 23/03/2016 and reporting for candidates to the allotted colleges was from 24/03/2016 till 03/04/2016. The allotment of PG Seats in Government Medical Colleges of Bihar has already been made during the first round of online counseling as per the vacancy position furnished by college concerned on INTRAMCC's Website and many candidates have already joined the allotted seats in medical colleges of Bihar.

It is noteworthy that the seats in question in Bihar have also been included in the total seats for first round and the candidates have already been allotted these seats under 50% All India Quota 2016.

Now, it is not possible for MCC of Directorate General of Health Services at this point of time to delete the seats and accommodate the candidates in second round of online counseling under 50% All India Quota 2016 in terms of the All India Quota Scheme in case they are not upgraded.

In view of the above and to avoid any legal complications in the matter, you are requested to adjust the candidates (who have been allotted PG seats in Bihar under 50% All India Quota 2016-17) against their All India Quota seats under intimation to the undersigned.

**Sub:- Regarding allotment of 50% All India PG Quota Seats.**

Sir,

In response to your above mentioned letter no. U-12021/56/2015-MEC, it is submitted that the present matter is under adjudication of the Hon'ble Patna High Court in C.W.J.C.No. 4759 of 2013 & Other analogous cases ( Dr. Madhukar & Others V/s The State of Bihar & Others) and the Hon'ble Patna High Court has passed an interim order dated 26.11.2015 and 08.02.2016 in the present matter, whereby the Hon'ble Court has specifically directed not to take any admission in the unrecognized PG Degree and Diploma courses.

2. The interim order dated 26.11.2015 passed in C .W.J.C. No. 4759 of 2013 is being quoted as hereunder.

*"The Court is also of the opinion that there cannot be any occasion to offer any courses for admission, for which there is no recognition by MCI in any of the Medical Colleges in the State of Bihar, because conduct of such courses or award of degrees does not accrue to the benefit of either the institution or the individual. Therefore, the Court is inclined to direct the State authorities not to conduct any examination for admission to any of these courses till they obtain recognition from MCI after putting the infrastructure as well as faculty in place."*

3. On 08.02.2016 the Hon'ble High Court further ordered that

*" The Court in its order dated 26.11.2015 gave a clear direction to the State authorities not to conduct any examination for admission to any of these courses till they obtain recognition from MCI by putting the infrastructure as well as faculty in place."*


4. It is also pointed out that the aforesaid interim order of the Hon'ble Patna High Court was passed in presence of the Counsel appearing on behalf of the MCI and therefore its compliance is also be ensured by MCI.

5. Apart from that, it has come to the knowledge of the Department that the Principal, Nalanda Medical College, Patna has already conveyed the situation with regard to possible change in the number of seats in PG courses, in the light of the above mention orders of the Hon'ble High Court on 04.03.2016 by its e-mail.

6. It is submitted that your direction issued vide letter dated 01.04.2016 cannot be carried out in view of the specific order of the Hon'ble Patna High Court.

This is for your kind information and necessary action.
