Changes in Online AIQ U.G Counseling Scheme for the year 2015

In compliance of the directions of the Hon'ble Supreme Court in Writ Petition (C) no. 298, 299,305 and 325 of 2015, order dated 19.06.2015, filed by Tanvi Sarwal Vs CBSE & Ors the Counseling Schedule has been prepared and the same is available on this website, the copy of Hon'ble Supreme Court is also available in notice section of this website.

According to the directions of the Hon'ble Supreme Court, order dated 19.06.2015, the Counseling has to be completed in time bound manner as directed by the Hon'ble Supreme Court. Therefore, the joining period has been accordingly reduced so that counseling process can be completed within time limit permitted by the Hon'ble Supreme Court.

In previous years the Counseling use to start before grant of permission by Central Government to start new Medical/Dental college, increase in MBBS/BDS seats in existing Medical/ Dental Colleges and renewal of permission to colleges started in last 4 years. Therefore, before start of Round -3 of online counselling newly created MBBS/BDS seats were added in the seats available (seat matrix) for Round 1 and 2 and candidates were required to fill up fresh choices before start of Round 3 of online counselling. During the current year i.e. 2015 the newly created MBBS/BDS seats are already known and included in seat matrix which is available on this website, as the Central Government has already granted permission to Medical Colleges and Dental Colleges on or before 15th June and 15th July 2015 respectively. Therefore, for the current year (2015) UG All India Quota online Counseling the Round 3 will also be an up-gradation round without fresh choice filling.

To prevent the blockage of seats of All India Quota, this year Counseling Committee has decided to provide facility of online resignation (in case candidate is not satisfied with allotted seat or wish to join MBBS/BDS seat allotted through State quota). Such candidates can submit online resignation by logging on to MCC website using their user name and password so that such seat is available to All India Quota candidates for allotment in Round 2 and 3 and thereafter for surrender to respective State. It is important to note that such candidates who have resigned online will not be eligible to participate in further rounds of counselling

Rest of the scheme for All India Quota online Counseling shall remain same as notified in Counseling Scheme Section of this website.

In view of the above the candidates are advised to:

1. Carefully read counseling scheme and note the above changes in scheme for the current year.
2. Study counseling schedule carefully.
3. Fill up choice of courses/ Colleges keeping in view the fact that the choices filled by the candidate will be valid for seat allotment for Round 1, 2 and 3. **There will be no fresh choice filling before Round-3.**
4. Fill up choice of courses/ Colleges keeping in view the time available for joining.
5. Exercise choice to participate in Round 2 / 3 carefully at the time of joining the allotted seat, keeping in view the time available for joining.
6. Original documents are required at the time of joining the course/ college allotted through All India Quota.
7. Joining time shall not be extended under any circumstances.

8. Candidates will be issued OTP (One Time Password) on their mobile phones which were registered at the time of registration for completing process of online resignation
9. Candidates who have resigned online will not be eligible to participate in further rounds of counselling
