Regarding Non-Transfer of vacant All India Quota UG seats (Session –2013) to States

In compliance of the order dated 29.08.2013 of Hon'ble Supreme Court of India in Writ Petition (Civil) no. 737 of 2013 in the matter of Lipika Gupta & ANR vs UOI & ORS the vacant All India Quota Under Graduate (MBBS/BDS) seats shall not be transferred to States till further order. The All India Quota vacant seats after completion of Round 3, must not be filled up by the States till further order.
