ORDER:

In the letter 2nd read above, the Director of Medical Education, Andhra Pradesh reported that in the states of Karnataka, Maharashtra, Orissa, Rajasthan, Tamilnadu and West Bengal there is a bounded obligation for rendering compulsory Government Service and at present in the state of Andhra Pradesh, as per the G.O.1st read above " one year compulsory Government Service shall be undergone after successful completion of medical Post Graduation / Diploma / DNB Course / Super Speciality Degree course under a bond obligation for Rs.20 Lakhs. The cumulative effect of Compulsory Government service under bounded obligation is one year only after completion of either MBBS or PG or DNB or Super Speciality course.

2) The Director of Medical Education has requested the Government to issue a fresh government order, stating that the student shall execute a bond for Rs.50 lakhs with an undertaking that they shall serve the Government for a period of not less than 3 years after completion of Super Speciality course.

3) The Government after careful examination of the matter, has decided to accept the proposal of Director of Medical Education and accordingly hereby order that the student who wish to prosecute Super Specialty Course in Government Medical Colleges shall execute a bond for Rs.50 lakhs with an undertaking that he / she shall serve the Government for a period of 3 years after completion of the Super speciality course.

4) The Registrar, Dr. NTR University of Health Sciences shall take necessary action accordingly.
