NOW THIS AGREEMENT

Consideration on the Govt. granting the student and facilities afore said the Govt. hereby agrees that the student shall Immediately on completion of the Degree course of his study the Govt. for period of not less than one year from the date of her completion of the Post Graduate studies in the capacity to

which she may be appointed according to the relevant service rule on the salary as she may be entitled to according to the post or service to which she may be appointed for one year as agreed or she shall be liable the Govt. to pay amount **Rs. 50,00,000/- (Rs. Fifty Lacs Only)** for post graduate degree. There will also be such proportionate penalty as may be determined by the state govt. and further all such some and any other sum due and payable under this agreement shall be recoverable from her arrears of land revenue and further that for the endorsement of this agreement shall be deemed to be bond for the performance of public duty which the public are interested.




