WHEREAS, the University has the option to call upon the obligor, Dr. _____ to serve the Rajah Muthiah Dental College & Hospital, Annamalai University for a period of one year on Contract Basis on the terms and conditions as may be prescribed by this Institution, depending on its exigencies, from the date of publication of results of the Examinations of the course pursued by him / her,

NOW, THEREFORE, the obligor Dr. _____ and I _____ to serve the Rajah Muthiah Dental College & Hospital on being called upon to do so for a period of not less than one year after completion of Post-graduate Course, the said obligor Dr. _____ or his/her legal heirs, executors and administrators shall forthwith pay to the University on demand and said sum of Rs,40,00,000/- (Rupees Forty Lakhs only) together with interest from the date of demand Government rate for the time being in force on Government Loans.

PROVIDED THAT if the obligor Dr. _____ shall pay back in the security amount of Rs. _____ (Rupees _____ only) , to the University, AND upon the obligor Dr. _____ or 1. _____ 2. _____ 3. _____ the sureties aforesaid making such payment, that above written bond shall be void and be of no effect, otherwise it shall remain in force and virtue:

PROVIDED always that the liability of the sureties hereunder shall not be impaired or discharged by reasonable time being granted or by any forbearance, act or omission of the University or any person authorized by them (whether with or without the consent or knowledge of the sureties) nor shall it be necessary for the University to sue the obligor before suing the sureties: 1. _____ 2. _____ 3. _____ or any of them for amounts due hereunder.

This bond shall in all respects to be governed by the laws of India, for the time being in force, and the rights and liabilities shall, where necessary, be accordingly determined by the appropriate courts in India.

This bond is exempted from stamp duty, under Article 57 of schedule-I of the Indian Stamp Act, 1899 (Central Act II of 1899).
