Medical College, AMU, Aligarh, on stipend and allowances as permissible by the University, w.e.f. _____ on the terms and conditions enclosed with this bond.

Further:

1. I undertake to refund the entire amount that I received as stipend along with **Rs.5,00,000/- (Rupees Five Lakhs)** as penalty in case I have the course without completing it and the University shall have every right to restrain me from appearing at the PG Diploma / Degree entrance test for the next three years from the date I leave the course.
2. I undertake and authorized the Registrar / Finance Office, AMU, Aligarh to deduct an amount of Rs.1,000 (Rupees One Thousand only) from the first payment as security amount to be refunded to me after completion of course and production of No Dues Certificates.
3. On completion of the course of the study if any amount is found outstanding against me, the same shall be deducted from the said security amount of Rs.1,000/-
4. I am neither entitled nor shall claim any interest on the security amount when refunded after completion of the course.
5. In case the change of specialty on account of second or third counseling, this bond shall remain in force and shall not be revoked and I shall be allowed to amend the specialty (if necessary on account of change of specialty) in the bond. The University shall be at liberty to pay the stipend on the basis of amended bond. However, the total period of which I shall be entitled for payment of stipend shall be counted from the date of initial admission to any such courses that is including the period preceding the date on change of specialty shall also be reckoned towards total period of admission to 36 months course, as the case may be.
6. That the attendance will be sent after submission of this bond and I shall not claim any stipend till this bond is accepted by the Registrar, AMU.

7. I undertake to abide by the leave rules as applicable to the Junior Resident Doctors and also the rules about removal of name from the rolls of the University as prescribed by the code of conduct and discipline rules enforce at present or subsequently.
8. I undertake to abide by the terms and conditions attached to the bond, which I have read, understood and accept, I have executed this bond with my free will and after understanding its contents fully.

TERMS AND CONDITIONS OF ADMISSION AS JUNIOR RESIDENT

The admission to post graduate Degree / Diploma Courses will be governed by the concerned Chapters of Ordinances (Academic) Chapter XLIII to L for all academic matters, during the period of admission as Junior Residents. The terms and conditions of admission shall be as follows:

1. TENURE

- i) The tenure of those admitted to post graduate degree course will be 36 calendar months from the date of admission and shall be 24 months for those admitted to diploma courses.
- ii) The report of progress will be monitored by the Chairman of the department and will be forwarded to Dean, Faculty of Medicine every three months.
- iii) Admission to Degree/Diploma Courses will initially be provisional and may be cancelled at any time owing to reasonable occasion:
 - (a) By the AMU, without any previous notice if the Chairman of the department/Dean, faculty of Medicine are satisfied, on Medical evidence, that the student is unfit and is likely to continue unfit for a considerable period of reason if ill health for the discharge of his/ her duties, PROVIDED ALWAYS that the above decision that the post graduate student is unfit and is likely to continue unfit, shall be final and binding on him/her.
 - (b) By the AMU, Aligarh or its authorized officer without any previous notice if the post graduate student is found guilty of non-performance, dereliction of duties, misbehavior, indiscipline and non-punctuality or any other misconduct as laid down in the AMU Students Conduct and Discipline Rules 1985, in force at present or subsequently enforced.

2. STIPEND:

- i) The amount of monthly stipend shall be fixed in accordance with the notification from the UGC.
- ii) An amount of Rs.1000/- will be deducted from the first payment as security deposit and the same will be returned after completion of course on receipt of clearance certificate from the Dean of the faculty of Medicine.
- iii) If the post graduate student is suspended from the duty in connection with any investigation into his/her conduct, he/she shall not be entitled to any stipend during such period of suspension but shall receive a suitable amount as may be decided by the Dean, Faculty of Medicine.

The total period of payment of stipend from the date of first admission to post graduate Diploma course shall be 24 months and Degree course shall be 36 months irrespective of the case of change of specialty, if any, from Diploma to Degree course or from Degree course to other Degree course.

3. WORKING HOURS:

Hours of work will be from 8:00 a.m. to 5:00 p.m. for clinical departments. Besides night calls, OPD and Emergency calls to Casualty Section will have to be attended as arranged by the Chairman of department. The daily work and teaching programme will be arranged by the Chairman of the department and any additional work due to exigencies in the department may be assigned by the Chairman of the department. Hours of work for non-clinical department shall be by the Chairman of the departments.

- i) 14 days Casual Leave in a calendar year which can neither be accumulated nor combined with Earned Leave.
- ii) 16 days Earned Leave to JR-I and 22 days Earned Leave to JR-II and JR-III in a calendar year which can be accumulated up to 36 days.

Note:

Leave account and attendance of PG students (who are working as Junior Residents) will be maintained by the Chairman of the department, and a copy of monthly attendance (indicating leave availed) will be forwarded to Dean, Faculty of Medicine.

4. MEDICAL CARE:

Medical Care will be the same as are available to the other students of the University.

5. CERTIFICATION:

Certification of completion of course will be issued, only after receipt of a satisfactory work and conduct report from the Chairman of the department concerned and after obtaining a 'No Dues Certificate' from the concerned University offices, Dean's Office, faculty Library, Dept./Hospital/Hall of residence etc.

6. OBSERVANCE OF RULES AND REGULATIONS:

- i) Every post graduate student shall be required to abide by all rules and regulation and orders, prescribed for them from time to time by the University Faculty of Medicine, J.N. Medical College Hospital.
- ii) Every post graduate student shall devote his/her whole time in such duties as are prescribed in pursuance of his/her course of study and shall not engage himself/herself, directly or indirectly, in any private practice, trade business, occupation or other profession. Violation of rules shall be treated as misconduct and shall make him/her liable to disciplinary action.

7. VERIFICATION:

I have gone through the above terms and conditions of my admission in pursuance of my course of study and accept them fully without any reservation. I also agree to abide by all the rules and regulations of J.N. Medical College Hospital and Aligarh Muslim University and other guidelines pertaining to medical ethics not mentioned in these terms and conditions.
