ORDER:

In the references 1st and 2nd read above, the Director of Medical Education, Telangana and Director, Nizam's Institute of Medical Sciences, Hyderabad have submitted proposals for obtaining bond at the time of admission to Post Graduate Courses. The details of which are as follows:-

- i. The Bond should be for a sum of Rs. 10,00,000/- (Rupees ten lakhs only) on admission to Postgraduate Diploma Courses for 2018-19 session and a sum of Rs. 20,00,000/- (Rupees twenty lakhs) on admission to Postgraduate Degree courses for 2018-19 session to be valid for one (1) year.
 - ii. The bond in the above manner should be obtained from non service candidates including candidates selected through 50% All India Quota.
 - iii. The bond should be accompanied by an undertaking that they shall serve the Government of Telangana, if required for a period of one year.
2. The Government after careful examination of the matter, hereby order to obtain the bond as per above mentioned details for admissions into PG Diploma / Degree courses.
3. The Director of Medical Education, TS, Hyderabad/ Director, Nizam's Institute of Medical Sciences, Hyderabad, shall take necessary further action in the matter accordingly.
