

## NOTICE

The Candidates are Advised to read the FAQ's and the Scheme of the counseling for All India Quota / Central University and Deemed University as uploaded in the **Counseling Scheme** on the MCC website (mcc.nic.in) before Registration and Choice Filling .

Specially the Fees Part

**Q.No. 1:- What are the various fee to be paid at the time of registration?**

Ans:- At the time of registration students have to pay two kinds of fee

- a) **Non Refundable Registration fee** Rs. 1000/- For UR candidates opting for counseling to AIQ /Central University and Rs. 500/- For SC/ ST/ OBC/ PH candidates  
Rs. 5000/- is to be paid for all Category students participating For Deemed University

**Refundable Tuition Fee** -which will be adjusted against the tuition fee of the candidate after he joins the allotted seat or if he is not allotted any seat in all rounds of counselling  
**Rs 25000/** For UR candidates opting for AIQ / Central University  
**Rs 10000** For SC/ST/OBC/PH Candidates opting for AIQ / Central University  
Rs 2, 00,000/ to be paid for all category students participating in Deemed univ

e.g 1)any UR candidate opting for Deemed University will have to pay Rs 5000/- non registration fee + Rs 2,00,000/-

Refundable fee at the time of registration e.g 2) Any SC candidate opting for AIQ only will pay registration fee of Rs 500/- + Rs. 10,000/- refundable tuition fee.

**Q. No. 2:- In case candidate had to apply for both AIQ and for Deemed University should the candidate pay the fee for both?**

Ans. No, in such case the candidate has to pay only the higher fee i.e. of Deemed University Rs. 5000/- and higher tuition fees of Rs 2 lakh

**Q. No. 3:- Is this tuition fee refundable in all the cases?**

Ans:- No, this fee will be forfeited if the candidate who has been allotted a seat in the second Round and Mop Up Round of DGHS does not join the respective institution during the second round / Mop Up round of counseling conducted by DGHS/MCC. Also the Tuition fee will be forfeited in case the candidate gives wrong information at the time of registration on the basis of which a seat may be allotted and later cancelled by the Admission Authorities at the time of reporting.

**Q. No. 4:- Where and when this fee will be refunded?**

Ans: - This fee will be refunded to the institution where the candidate has taken admission and will be adjusted against the first year annual fee. This fee will be refunded only after the counseling is completed.

Also the fees will be refunded to candidates account if he is not allotted any seat in any of counselling rounds of DGHS

**Q. No 5:- When will the net banking facility for payment of fees start?**

Ans:- Net banking facility is likely to start from 19/3/18

**Q. No 6:- I have opted for Deemed University by mistake for counseling and want to participate only in All India Quota at the time of registration or vice versa?**

Ans :- Reset/ Reinitialising Facility may be made available soon , however Candidates are advised to fill their options carefully while opting for the type of counselling ( All India / Deemed /Central Univ / AFMS etc) at the time of registration

**Q. No 7:- I am getting the message “You are not permitted to fill up choices online for counselling” what could be the issue**

Ans: - Candidates are advised to check if they have opted for Central University counselling, in case the candidate does not belong to Delhi Univ, AMU or BHU or does not fulfil their eligibility conditions. In the above scenario you may get the above message
