It is for the information to all candidates that as per the information from MoHFW vide Letter No. V.12025/143/2019-DE dated 6th Sept. 2019 in consultation with Dental Council of India (DCI), the qualifying cut- off percentile for admissions to BDS courses has been reduced by **10.00 percentile** for each category (General, SC/ST/OBC and Persons with Disability) in pursuance of the clause (b) of Chapter 6: Merit List and Qualifying Criteria of the Information Bulletin for NEET (UG)-2019. The Qualifying percentiles for NEET UG 2019 for admissions to BDS courses for the academic session 2019-20 stands lowered as under:

S/ No.	CATEGORY	QUALIFYING PERCENTILE
1.	General	40
2.	SC/ ST/ OBC & PwD of SC/ST/OBC category	30
3.	General PwD	35

In view of the above the candidates who have become eligible after lowered cut off can register on MCC website as per the schedule uploaded on MCC website. The candidates who are already registered need to report to the colleges/ Institutes directly for participation in Stray Vacancy Round for BDS seats. The **eligibility of candidates for Stray Vacancy Round will be as under:**

1. Candidates who haven't been allotted any seat in earlier rounds conducted by MCC are eligible.
2. Candidates who have become eligible after reduced percentile can do fresh registration and report directly to the colleges for participation in Stray Vacancy Round. For further information kindly contact the concerned college.
